# Certificate Of Incorporation Of DrupalNYC Incorporated

Under Section 402 of the Not-for-Profit Corporation Law

**First:** The name of the corporation is DrupalNYC Incorporated.

**Second:** The corporation is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-for-Profit Corporation Law.

**Third:** The corporation is formed for charitable, educational and scientific purposes within the City of New York that further knowledge and development of Drupal, a free and open source internet content management system that is distributed under a free and general public license.

**Fourth:** The corporation is not formed to engage in any activity or for any purpose requiring consent or approval of any state official, department, board, agency or other body. No consent or approval is required.

**Fifth:** The corporation is a charitable corporation under Section 201 of the Not-for-Profit Corporation Law.

**Sixth:** The office of the corporation is to be located in the County of New York, State of New York.

**Eighth:** The Secretary of State is designated as agent of the corporation upon whom process against it may be served. The address to which the Secretary of State shall mail a copy of any process accepted on behalf of the corporation is:

**Ninth:** The corporation shall not operate a school, college, university or other entity providing post-secondary education; nor library nor museum nor historical society in pursuit of its educational purpose set forth in paragraph THIRD.

**Tenth:** The following language relates to the corporation's tax exempt status and is not a statement of purposes and powers. Consequently, this language does not expand or alter the corporation's purposes or powers set forth in paragraph THIRD.

(a.) The corporation is organized and operated exclusively for charitable, educational and scientific purposes within the meaning of 501(c)(3) of the Internal Revenue Code.

(b.) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(c.) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in paragraph THIRD.

(d.) Notwithstanding any other provision of this Certificate, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.



(e.) Upon the dissolution of the corporation, its assets shall be distributed to DrupalCon Inc., provided that DrupalCon Inc., at the time of such dissolution, qualifies as an exempt organization within the meaning of section 501(c)(3) of the Internal Revenue Code. If at such time DrupalCon Inc shall not qualify or be unable to accept the assets of the corporation, then the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
